- Master of Arts (MA) and Doctor of Philosophy (PhD) degrees in Communication Studies-Rhetorical Studies (23.1304.00), and
- Master of Arts (MA) and Doctor of Philosophy (PhD) degrees in Communication Studies-Interpersonal Communication (23.1304.00).
