Students who know they intend to complete the Architectural History minor should apply online at the earliest possible date; deadlines are March 1 for fall or summer, and October 1 for spring.

To fulfill the Architectural History Minor students must complete fifteen semester hours of coursework as described below. At least half of the coursework must be completed in residence at The University of Texas at Austin. All coursework must be taken on the letter-grade basis, and completed in conjunction with the students' major requirements. Six hours must be upper-division.
