

If an objection is filed within the prescribed period, the legislation will be presented to the Faculty Council at its meeting on May 2, 2016. The objection, with reasons, must be signed by a member of the Faculty Council.

To be counted, a protest must be received in the Office of the General Faculty by April 29, 2016.
