On September 7, 2016, UT Austin was informed that the Board of Regents modified the Regents' Rule 20201 so that changes to the *Handbook of Operating Procedures* will no longer require UT System approval. Final approval of these changes will reside with the Vice President for Legal Affairs and the President.
