# Standing Committee C-6: International Programs and Studies Committee

#### Convening, Participation, and Prior Outcomes

The Chair convened the meeting of The University of Texas at Austin's (UT) Faculty Council's (FC) International Programs and Studies Committee (hereafter the C-6 Committee) around 1:00 PM on Monday, February 20, 2017. At the February 20 meeting time, C-6 Committee member decided not to meet on the March 6, 2017 meeting and seek to arrange via doodle-poll a longer, ninety-minute meeting during the week of April 10, 2017 to accomplish a number of final deliverables for the 2016-2017 academic year (the April C-6 meeting). #### Agenda Items, February 20, 2017

#### **Item 1: How to Support UT International Office**

The C-6 Committee discussed how to assist the International Office in its effort to increase UT student participation in semester-long international programs abroad managed by local universities, where the content has been preapproved by UT departments for undergraduate academic credit. The C-6 Committee discussed draft correspondence for a so-called University Ambassador program. The Committee agreed to revise the correspondence, seek to adopt it in the April meeting. If the correspondence is adopted, the C-6 Committee would present the concept for the University Ambassador Program to the Faculty Council in May 2017 for implementation during the 2017-18 academic year.

# Item 2: How to Support UT International Engagement – UT President's Office

The C-6 Committee agreed to review a draft survey being developed by the UT President's Office's (UTPO) to understand the diversity of international engagement at UT. The UTPO will ask the C-6 Committee to review the forms at the April meeting. The Chair reported that Professor Joshua Eisenman of the LBJ School had agreed to review the draft forms in advance of the April meeting to provide early feedback to the UTPO.

## Item 3: Guidance for Faculty Leading Study Program Abroad

Heather Thompson discussed International Office (IO) efforts to improve guidance materials for faculty members considering taking students abroad. The C-6 Committee agreed to review the draft IO documents at the April 2017 C-6 meeting.

# Item 4: Faculty Responsibilities for Student Welfare While in International Programs

The C-6 Committee agreed that it will complete by April 2017 a draft report concerning faculty responsibilities for student welfare while participating in UT-sanctioned study, research or service abroad. Such information on faculty responsibilities for student welfare would inform faculty members considering taking students abroad. If the C-6 Committee approves the draft report in April 2017, the C-6 Committee will discuss the idea of the report with the Faculty Council in its May meeting. A final report would be prepared in 2017-18.
