## Hugh L. Brady, Clinical Professor, School of Law

As a customer of the University Coop for many years, I have a keen appreciation of the role it plays in the UT community. I also understand the modern retail environment is demanding as customer tastes and shopping trends continue to change rapidly. My professional and academic experience is centered on fast-moving environments and helping principals and teams adapt to change. As director of the Legislative Lawyering Clinic, I prepare students to practice law in high-stakes, demanding settings where the client's needs can change overnight depending on the real-time effects of political, economic, and social events. I have succeeded in the same environment as a practicing lawyer. I've also advised elected officials and local governments across Texas on a number of significant matters related to local government finance, including bonds and tax increment financing. For almost three years, I was on leave to serve at the White House as the general counsel for administration; I was the chief legal adviser for over \$75 million in specialized procurement efforts and the appropriation and internal oversight of roughly \$400 million in operating funds for the Executive Office of the President. With this experience, I think I would bring a unique perspective to the board as it continues to manage operating challenges.

# REPORT OF THE COMMITTEE TO NOMINATE FACULTY MEMBERS FOR APPOINTMENT TO THE UNIVERSITY CO-OP BOARD OF DIRECTORS

Each spring the chair of the Faculty Council appoints a committee to nominate a panel of the General Faculty of The University of Texas at Austin for appointment to the University Co-op Board of Directors. The panel shall, upon approval by the Faculty Council, be transmitted to the President with the recommendation that he or she select one representative from the panel for appointment to the University Co-op Board of Directors to serve a four-year term of service. If the President declines or, because of rejection of the post by all nominees, is unable to appoint any of the nominees, the President may either request that the Council, through its committee, make additional nominations or invoke a different procedure for selecting the appointees as he may deem appropriate, provided that such different procedure shall include consultation with the Council's committee before the President offers the appointment to any faculty member.
