QUESTION TO PRESIDENT FOR OCTOBER 8, 2018 Annual Meeting of the General Faculty

To President Fenves:

In a legal brief in your official capacity as president of the University of Texas at Austin, you joined the State Attorney General and several regents in questioning the existence of academic freedom and furthermore denying that individual professors have an academic right to free speech (cf. https://www.tribtalk.org/author/thomas-g-palaima/ and https://www.tribtalk.org/author/thomas-g-palaima/ and https://www.tribtalk.org/author/alberto-martinez/). If so, individual professors are left with no guarantee that our university will defend their right to express themselves freely. Individual professors might then be censored both from within the university and from outside. We appreciate that you have already made public statements distancing yourself from the claims about academic freedom in the appellee brief. Still, the legal document is unsettling.

Professors deserve and need institutional guarantees that they are safe to exercise their individual academic free speech. Relying on the good will of individual administrators is no guarantee. Curtailment of free speech does not require that the administration actually penalize anyone for their expressions. The mere possibility of being penalized may silence some professors.

Please explain what can be done formally to reassert institutionally the importance of academic freedom at our university.
