

## REQUEST FOR FINAL ORAL EXAMINATION INSTRUCTIONS

Submit your dissertation/treatise to your Dissertation Committee at least four weeks before your defense. The typed Request for Final Oral Examination form must be submitted to the Graduate School at least two weeks before the date of your final examination.

By signing this form each member of your Dissertation Committee acknowledges they have received your doctoral dissertation with sufficient time to complete a careful review of the dissertation (typically four weeks in advance of the defense). They also agree to attend (physically or virtually) the final oral examination. Each member must sign for themselves. **No proxy signatures will be accepted.**

Additionally, by signing this form your supervisor acknowledges that you have received any necessary IRB approvals if your work involves human participants. If so, please supply the IRB study number in the space provided under the supervisor's signature line.

Students who have officially registered a "name in use" with the Gender and Sexuality Center may use their registered name on this form. Please note that the name you use on this form (either your legal name, or your officially registered "name in use") will be the name the Graduate School will use on your Report of Dissertation Committee and the name that you should use on your dissertation.
