The commencement date contemplated above and any obligations of the parties shall be postponed during all periods any act of God, fire, strike, labor controversy, law or governmental act interrupts normal business operations or production of the picture, plus such additional period of time as may be reasonably required to recommence production of the picture.
3. FILMMAKER'S RIGHTS:
Filmmaker shall own all rights of every kind in and the motion picture/video and other photography made hereunder, including the right to utilize the same in connection with the production titled and in connection with any other productions or any manner whatsoever, whether now known or hereafter known, in any and all media now known or hereafter devised in perpetuity and throughout the universe. If there is any breech by Filmmaker, Owner shall be limited to an action law for damages, and shall not be entitles to terminate this Agent or rescind the rights granted or to enjoin or restrain the development production, or exploitation of the picture.
4. INDEMNIFICATION OF PROPERTY:
Filmmaker shall indemnify and hold Owner harmless from and against any and all damages and liability for injury to or death of persons and for damage to or destruction of property of the Owner occurring, during Filmmakers use of said premises and caused by Filmmakers or any of its employees in the conduct of Filmmakers motion picture/video operation under and pursuant to this agreement, provided, however, that Filmmakers comprehensive general liability under this clause shall be limited to the amount of Filmmakers comprehensive general liability insurance.
5. RELEASE: Neither Owner nor any tenant, or other party now or hereafter having an interest in the Property, shall have any right of action, including but not limited to, those based upon invasion of privacy, publicity, defamation, or other civil rights, in connection with the exercise of the permission and/or rights herein granted.
6. REPRESENTATION AND AUTHORITY: Owner/Manager represents that he/she is the owner and/or authorized representative of said premises and that Owner/Manager has the authority to grant to you the permission and rights herein granted, and that no one else's permission if required.
