Dear Ms. Haster:

The National Science Foundation (NSF) has completed the review and resolution of the Office of Inspector General (OIG) audit report on costs incurred under NSF awards by the University of Texas at Austin (UT Austin) during the period of December 1, 2013 through November 30, 2016.

The audit report questioned a total of \$283,613 in costs claimed under NSF awards and recommended that UT Austin strengthen its administrative and management controls for the areas in which findings were identified. Based on UT Austin's agreement with the findings and questioned costs identified in the audit report, NSF's management decision is to disallow all questioned costs in the amount of \$283,613. The table below summarizes the disallowed costs by funding number:
